

**Join Councilmember Kevin Faulconer to
Say No to Proposed Airport Parking Structure:
Rally on Tues. April 29, 12:30 at Spanish Landing**

Dear neighbor:

This coming Thursday, May 1st, the San Diego County Regional Airport Authority has decided it will vote on its plans to build a five story, 5,000-space parking structure on North Harbor Drive.

The Airport Authority Board is rushing to certify the Environmental Impact Report (EIR), giving the public less than 2 weeks to review the final 2,000 plus page document which outlines the multi-million dollar Master Plan.

After discussing this with neighbors from across the district, **Councilmember Faulconer has decided to hold a rally to request:**

- 1) The removal of the massive parking structure from the plan; and**
- 2) Adequate time for the community to review the final 2,000+ page proposal.**

The rally will be held at 12:30 on Tuesday, April 29 at Spanish Landing Park in preparation for the May 1 Airport Authority Board hearing.

No Parking Structure, No Shoehorning Traffic

Councilmember Faulconer and community leaders are asking the Airport Authority to remove its proposal for a five story, 5,000-space parking structure to be built on North Harbor Drive. This parking structure would bring more traffic gridlock and pollution to the already-congested roads that connect our neighborhoods.

The Airport Authority's own EIR acknowledges that the structure will result in "significant impact" to streets surrounding the airport, resulting in F-rated Levels of Service due to increases in traffic.

More Time for Community Review

Councilmember Faulconer and community leaders are also advocating that the Airport Authority give the community adequate time to weigh in on the final EIR.

Less than two weeks notice is not enough time to read and consider the Airport Authority's final multi-million dollar Master Plan.

From I-5 (Mission Beach, Old Town)

Take I-5 South

Exit Sassafras/San Diego Airport

Merge onto Kettner Blvd.

Right at W. Laurel St.

Slight right at North Harbor Dr.

Turn left at "Spanish Landing" intersection (across from Terminal Two)

From the West (Midway, Point Loma, Ocean Beach)

Take Rosecrans St. south-west

Left on North Harbor Dr.

Continue east on North Harbor Dr.

Turn right at "Spanish Landing" intersection (across from Terminal Two)

From the East (Downtown, Mission Hills, Uptown)

Drive west on W. Laurel St.

Merge onto North Harbor Drive

Turn left at "Spanish Landing" intersection (across from Terminal Two)
